FROM THE MANAGER

It's a Matter of (Co-op!) Principles Part II

For me, this is a time of year for reflection, and topping my list of things I'm grateful for is our wonderful community. I know I speak for all Prairie Land Electric employees when I say we are thankful to be in such an incredible community. We are fortunate to live in the same place where we work, which makes our ties to this community that much stronger.

You may recall last month, my column touched on the first three Cooperative Principles, so this month, I'd like to tell you about the remaining four principles. The Cooperative Principles are essential to the co-op business model and benefit all members of the co-op.

Autonomy and Independence

The fourth principal, Autonomy and Independence, means that the co-op operates in an autonomous way that is solely directed and guided by its members, reflecting the values and needs of our local community. This means the coop is not being influenced by leaders or shareholders several states away. Instead, the co-op is led by the local members it serves.



Education and Training

The fifth principle, Education and Training, focuses on enhancing the knowledge of co-op employees and board members, which enables them to contribute to the development of the co-op.

By investing in continuous learning for our employees and board members, our co-op is making a commitment not just to individual professional and personal growth, but to the future of the co-op and the high quality of service our members expect and deserve. It's a win-win situation.



Notice to Members: Proposed Rate Changes

In September, we informed you that Prairie Land was undergoing a rate study — a process that evaluates the cooperative's costs of providing electric service and rates charged for this service. The purpose of this study was to (1) identify the overall revenue needed to cover Prairie Land's operating expenses and debt obligations while generating enough capital to reinvest in our electrical system and (2) review the cost of providing service to each individual rate class (i.e., residential, commercial, irrigation, etc.). This study, performed by an outside independent rate consultant, has now been completed. On Tuesday, Nov. 23, 2021, at 1 p.m., the board of trustees will hold a member rate meeting at the Norton office.

Action on the retail rates may be taken at that time. The meeting is open to any member who wishes to attend and hear the rate proposal presentation.

Rate Study Results

The study showed that overall electric rate revenues should be increased by \$5.6 million, or about 8.3%, in 2022. After considering the magnitude of the potential financial impact to our members, Prairie Land's board elected to lower the margins to the bare minimum but still adequate to meet loan covenants set by our lender. Additionally, we will phase in the

increase over three years instead of adjusting rates in a single year.

After the adjustment to margin requirements, the required revenue increase for 2022 was reduced to \$2.5 million, or about 3.9%, with an additional \$900,000 needed in 2023 and \$1.2 million in 2024. If approved by the board of trustees, the proposal will become effective on Jan. 1, 2022.

Rate Change Summary

Rate design entails a balancing act between meeting our revenue needs and minimizing our members' financial impact. While the cost-ofservice (COS) study indicates the need for a 3.9% increase in overall rate revenue, some rate classes will require more than the average, while others may need little or no increase. As a not-for-profit organization, we must recover our costs of doing business and maintain sufficient margins to reinvest in our electric distribution system.

The amount of the rate change will vary by rate class. This is because the cost to provide service varies with each rate class depending on the size of the loads and the relative level of consumption. Some increases indicated by the COS were more significant, yet as proposed, the average increase to any affected customer class was capped at 9.8%.

The table above gives an overview of the proposed rate changes by rate class. The percentages shown reflect the impact for the average usage customer within the class. However, the effect to each member within each rate class will vary depending on individual consumption.

Keep Safety on Your Holiday Menu

The kitchen can be a busy place during the holiday season, and it's important to keep electrical safety in mind.

According to the National Institutes of Health, the United States has 30,000

shock incidents per year, and approximately 1,000 deaths.

Watch for these shocking kitchen hazards:

- Damaged or worn electrical cords
- ► Appliances with improper or faulty wiring
- ▶ Damp cloths or water near sources of electricity

Following these tips may help prevent electric shock in your home:

- ► Always read and follow an appliance's operating instructions.
- ► Always dry your hands before handling cords or plugs.
- ► Ensure appliance cords are thoroughly dry before plugging them in.
- ▶ Pull on the plug, not the cord, to disconnect an appliance from an outlet.
- Discard any item with a cord or plug that has damaged insulation or exposed wiring, or that is frayed, cracked, taped or otherwise questionable.
- Do not overload extension cords, multipack "power strips" or surge protectors and do not plug them into each other. These are only for temporary use.
- Never remove the third (round or Ushaped) prong from a plug, which is a grounding/safety feature designed to reduce the risk of shock and electrocution.
- ► Have your home inspected by a licensed electrician.
- ► Educate your household on how to properly turn off your home's power in case of an emergency.

Nominations may also be made by petition. Interested candidates should contact the Norton office to request the appropriate form.

The petition must be signed by not less than 25 members of the district for whom the trustee is to be elected. Petitions need to be delivered to the Norton office by 5 P.M. ON JAN. 11, 2022. All nominations shall be posted in the Norton office.

The election shall be conducted on an "at large" basis; therefore every member of Prairie Land Electric is eligible to vote for all positions in the election. Upon completion of the nominating process, voting materials will be mailed to Prairie Land members **BY JAN. 25, 2022.** The bylaws, as amended, require the use of mail ballots for trustee elections.

Ballots and a postage paid return envelope will be furnished for the member to use. Ballots must be returned to the Norton office by 5 P.M. ON FEB. 10, 2022. An Election and Credentials committee will count the ballots by Feb. 20 and the election results will then be announced.
