6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and clean up:

Shut off all possible sources of ignition. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

7. HANDLING AND STORAGE

Conditions for safe storage:

Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Engineering controls:

Use in well ventilated areas. If inhalation risk exists: Use with local exhaust ventilation or while wearing organic vapour respirator. Vapour heavier than air - prevent concentration in hollows or sumps. DO NOT enter confined spaces where vapour may have collected. Keep containers closed when not in use.
